### Curriculum:

Are we required to purchase these additional curriculums?

- Yes. For any layered curricula directors must purchase curricula for use in ECEAP classrooms. The information on what curricula needs to be purchased is contained in the letter you received.

Are the options listed the only options that are "approved" curriculum?

- Not necessarily, however, any layered curricula approved for purchase needs to be research-based. If you want to purchase something different than what is on the list, please reach out to your CQI for approval.

There is a comment about the site being responsible for training... would the funds need to include this cost? Or would that be a district cost? Thanks for helping us get new curriculum

- We understand that this funding may not cover all the curriculum and training that you need. We want you to purchase this curriculum and use any leftovers towards training. Additional ECEAP funds may be used to dedicate to the training as well.

General statement:

- These purchases need to happen after July 1 and occur during FY 24. Even though you are getting these funds in June, these purchases must be made in FY 24.

What do you need from us for this purchase?

- We need a plan on what curricula you plan on purchasing, when you will purchase it, and an estimate on when training will be provided.

What if we have layered curricula in classes that isn't noted in ELMS?

- Please let us know this information as soon as possible and update it in ELMS as soon as possible.
